Greetings from PDEXCIL,

Dear Members,

As you are already aware as per Trade Notice No.35/2021-2022 issued on dated.24.02.2022 and PDEXCIL MUM/NEW MEM/13/2021-22/ 431, Dtd: 30.03.2022, DGFT has implemented the electronic platform to facilitate electronic issuance/renewal/amendment of Registration Cum Membership Certificate (RCMC)/Registration Certificate (RC) and it has been made mandatory to apply RCMC application through common digital RCMC portal only and members can pay their issuance/renewal/amendment charges through **online and offline** payment mode.

Now this council has received intimation from the DGFT regarding discontinuation of **Offline payment** facility on eRCMC portal w.e.f 15<sup>th</sup> June 2023. **Hence, members who have already paid renewal fees directly to the council are requested to please renew your RCMC through DGFT portal on or before 14.06.2023 compulsorily and non renewed members are requested to renew your membership through DGFT portal only.**
