SUB: EXTENSION OF RENEWAL OF MEMBERSHIP FOR THE FY 2024-25

Dear Member,

Please note that, in terms of clause 13(a) (i) of the Articles of Association of the PDEXCIL, the membership of the council is on yearly basis (Financial Year April-March) and is required to be renewed from 1st April 2024. Moreover on failure to pay subscription or dues, except penalty on the expiry of a period of three months (i.e 30th June 2024) from the date on which the subscription or dues fell due which shall be 1st April of every year, and no member whose subscription is in arrears at the time of such voting shall be entitled to vote. However if the member renew their membership after expiry of the above said three months period (i.e.30th June 2024) they may continue as member without any voting power for the said financial year (i.e FY 2024-25).

Accordingly this council had already extended the renewal of membership period via circular no. PDEXCIL MUM/MEM RENEWAL/27/2024-25/111, Dtd:01.07.2024, upto 15.07.2024 and via circular no. PDEXCIL Mum/COA/18/2024-25/125, dtd. 12.07.2024, upto 31.07.2024 but even after that some members of the Council have not renewed their membership till date. **Hence it has decided to extend the renewal of membership last date upto 30.08.2024** along with all voting rights as per new Model Articles of Association/Bye-laws by Export Promotion Councils/FIEO the Letter No. 13/3/2023-E&MDA- DoC Part-I dated- 25th July, 2024. Members are requested to renew their membership on or before 30.08.2024 as per below procedure.

For RCMC Holders: In reference to the Trade Notice No.35/2021-2022 issued on dated.24.02 2022 by DGFT it is to inform that, DGFT has implemented the electronic platform to facilitate electronic issuance/renewal/amendment of Registration Cum Membership Certificate (RCMC)/Registration Certificate (RC) and it has been made mandatory to renew/apply RCMC application through common digital RCMC portal only. **Steps to apply for RENEWAL OF RCMC is mentioned in the attached file at point no 2.3.Renewal of Registration-cum Membership Certificate from page no.29 to 39.**


