 - iii. **02 (Two)** Seats are reserved for categories of Women Entrepreneurs, Startups, Young entrepreneurs (less than 40 years of age as 31st March of the year of election); and North Eastern/Hill regions to ensure their suitable representation in the Committee.
- **Proposer and Seconder** should be an ordinary member eligible to vote as per above circular para 4.1 and **must attached Chartered Accountant Certificate** for export performance.
