TERMS & CONDITIONS:

- 1. Trainee handbook, uniform and Bag/File should be PDEXCIL & MOT Branded.
- 2. Delivery of the Trainee kits to be done at the approved training centers address.
- 3. Payment per trainee kit is inclusive of all Transportation expenses incurred.
- 4. Trainee Kit Acknowledgement report to be received and submitted to PDEXCIL which is to be authorized by all trainees & training centers.
- 5. Trainee kit to be supplied to all enrolled candidates subject to a cap of 9000 kits, however payment will be a total of 7000 kits and in proportionate to the no. of candidates successfully trained and assessed.
- 6. Additional trainee kits provided shall be charged at the quoted value
- 7. PDEXCIL will be free to modify, alter, re-locate or any other changes if and when necessary.
- 8. The bidder should possess TAN/PAN/VAT/GST/Income tax as applicable by the prevailing laws of the country.
- 9. The proposal/bids shall be submitted along with the tender fee of Rs.5,000/- (Non refundable) and earnest money deposit of Rs.1,00,000/- of the total project cost and documentary proof of experience to the PDEXCIL office by hand delivery, post/courier or such means in closed/sealed envelope marked "Supply of Trainee Kits / Learning Materials under SAMARTH Scheme" tender and submit to the below mentioned address.
- 10. The successful bidder shall execute an agreement with PDEXCIL with the details of work and shall keep deposited 5% amount of the total project cost as performance security, which will be released after successful completion of the work.
- 11. The last date for submission of bids will be 10 days from the date of publication of advertisement.
- 12. The decision of PDEXCIL will be final and binding.

PAYMENT TERMS: Payment will be in 4 terms 30%-30%-30%-10%,

1st Instalment - 30% advance against the PO value

 2^{nd} Instalment – 30% advance on submission of consolidated bills proportionate to 1st instalment value, supply of kits to the training centers in proportion to the targets achieved and submission of necessary proof of evidences/documents

3rd Instalment – 30% on submission of consolidated bills proportionate to 2nd instalment value, supply of trainee kits proportion to the targets achieved and submission of proof of documents

4th Instalment - 10% - on submission of consolidated bills proportionate to 3rd instalment value, supply of trainee kits in proportion to the targets achieved and submission of proof of documents

Monthly invoices to be raised to PDEXCIL proportionate to the number of trainees enrolled in the batches created and approved under SAMARTH Scheme. Annexes of the invoices should contain the Trainee kit acknowledgement proof (Training centre wise & Batch wise) as proof of evidence.
