Mode of Payment:

For online mode: In reference to the Trade Notice No.35/2021-2022 issued on dated.24.02 2022 by DGFT it is to inform that, DGFT has implemented the electronic platform to facilitate electronic issuance/renewal/amendment of Registration Cum Membership Certificate (RCMC)/Registration Certificate (RC) and it has been made mandatory to renew/apply RCMC application through common digital RCMC portal only. **Steps to apply for RENEWAL OF RCMC is mentioned in the attached file at point no 2.3.Renewal of Registration-cum Membership Certificate from page no.29 to 39.1**
